

How to complete the Appointment of a Nominated Representative Form

Part 1 – Applicant(s) details

To complete this section, you must fill in the personal details of the investor/s.

If you already hold a BlackRock account, please record your existing Investor Number in the space provided.

If you have invested for someone under 18, record your own name as investor, then write “For and on behalf of (child’s name)” in the Trustee Section of Part One. The appointment of a nominated representative form must be signed by the adult.

Part 2 – Nominated representative details

Please complete the name and address details of your nominated representative in this section.

Anti-Money Laundering and Counter Terrorism Financing

BlackRock is required to comply with the Anti-Money laundering and Counter-Terrorism Financing Act 2006 (“the AML legislation”).

In accordance with the AML legislation BlackRock is required to verify the identity of legal representatives and agents appointed to act on behalf of an investor. We cannot proceed to act on the instructions of a nominated legal representative until such time as we verify the identity of that representative.

Appointed legal representatives include, but are not limited to, executors of estates, attorneys (appointed under power of attorney) and nominated representatives.

Part 3 – Signatures

Joint investments must be signed by all investors.

Corporations must sign (a) under seal; (b) by two directors or a director and company secretary; or (c) by sole director (where applicable). Please also state your title, e.g. Director, Company Secretary or Sole Director.

If signed under **Power of Attorney**, the attorney certifies that they have not received notice of revocation of that power. **Please enclose a certified copy of the Power of Attorney** when you return the nomination form.

Appointment of nominated representative

By completing the details on the form you can appoint a nominated representative to act as your representative or agent in relation to the Fund(s) you have invested in. This appointment is subject to the following terms and conditions. Please read them carefully. Your nominated representative will be permitted to:

- apply for units on your behalf
- amend your instructions as to how your income will be paid
- amend your selected Fixed Distribution Option and Regular Payments Facility (if applicable to fund)
- request a withdrawal in writing of your investment
- change your registered address
- make enquiries regarding your investment
- make any transactions incidental to any of the above

Directions or enquiries from a person believed by BlackRock to be your nominated representative shall be deemed to be your personal acts.

BlackRock will continue to act upon any instructions from your nominated representative until BlackRock receives a written cancellation of the appointment.

BlackRock may cancel or vary the terms of this appointment by giving you 14 days notice.

Where your nominated representative is a company or partnership the power you have vested in the nominated representative shall be deemed to extend to any director, partner or authorised officer of the nominated representative notified to BlackRock.

You agree to release, discharge and indemnify the relevant Fund and BlackRock from and against all losses, actions, liabilities, claims, demands and proceedings arising from your appointment of a nominated representative and that neither you nor any person claiming through you will have any claim against any of them in relation to any transaction or dealing made at the direction of your nominated representative.

You agree that if a payment is requested, made or received by your nominated representative such payment shall constitute a discharge of the obligations of either BlackRock under the constitutions and that neither you nor any person claiming through you will have any claim against the Fund or BlackRock.
