To assist in understanding how the new fund names relate to those you have been familiar with in the past, the table below summarises the naming conventions to be employed in the future.

New naming convention basis

BlackRock Indexed	This refers to the range of index funds that each seek to match the return of their respective benchmark – with a strong focus on managing risk, return and cost.
